POSITION AVAILABLE: Invasive Species Field Technician (Multiple vacancies)

Work location: Based in Marquette, MI, with daily travel throughout Alger, Delta, Marquette, and Schoolcraft counties

Application deadline: Friday, February 23, 2024 by 4:00pm Eastern

Anticipated Start Date: May 13, 2024

General Conditions: This is a part time, seasonal position, averaging 32 hours per week from May through August. Flexible work schedule will typically be Monday through Thursday each week. Employee will be directly supervised by the Lake to Lake CISMA Coordinator, with additional supervision provided by the Lake to Lake CISMA Program Coordinator and the Marquette County Conservation District Manager. This position serves as an invasive species field technician for the Lake to Lake Cooperative Invasive Species Management Area. More information can be found at www.l2lcisma.org

Essential functions include:

1. Assist with invasive species field surveys, mapping, and management.
2. Assist with data management and invasive treatment activities.
 - a. Use handheld GPS unit and ESRI software to collect field data.
 - b. Enter field data according to Lake to Lake CISMA data management protocols.
 - c. Conduct vegetative surveys of native restoration sites and participate in native restoration activities.
 - d. Conduct invasive species management objectives including hand pulling, cutting, mowing, chemical applications, and other best management practices.
3. Related duties
 - a. Assist with optional outreach events throughout the duration of employment.
 - b. Perform other related duties as assigned by supervisor.

Desired qualifications:

1. **Education:** Bachelor's degree, or current student working towards biology/natural resources/agriculture degrees, or persons with background in natural resources preferred. Coursework related to GIS, botany, or ecology a plus.
2. **Experience:** Field experiences with native and invasive species identification, GPS & GIS use, and public speaking. Willingness to become a certified Michigan Pesticide Applicator and/or prior certification upon application a plus. Willingness and experience working on or around water, and with small watercraft a plus.
3. Other: **Applicant must:**
 - a. Have reliable personal transportation for work-related use; must maintain valid Michigan driver's license.
 - b. Be able and willing to work efficiently and independently outdoors in a variety of conditions and terrains, carrying field supplies up to 50lbs.
 - c. Be able to work cooperatively with District and Agency personnel, L2L CISMA partner agencies, and the general public.
 - d. Exhibit excellent attention to detail in collecting and recording field data.
 - e. Be prepared to wear personal protective equipment whenever applicable.

Compensation: \$17 - \$19/hr.; mileage reimbursement at the current federal rate for travel in personal vehicle (\$0.67/mile)
